I am desired to invite your attention to the Commission's communication No. F-6-1(II)/2006 (CPP - I) dated 19<sup>th</sup> August 2009 addressed to the institutions declared by the Central Government as institutions "deemed to be universities" under Section 3 of the University Grants Commission Act 1956 [3 of 1956] withdrawing, in pursuance of the Ministry's communication in F.No. 2-18/2009 - U 3(A) dated 10<sup>th</sup> August 2009, the Commission's notification No. F. 6-1 (II) /2006 (CPP - I) dated 13/9/2006 and the subsequent corrigendum No. F 6-1 (II)/2006 (CPP - I) dated 20/2/2008; and also to a request (copy of enclosed) for a 'No Objection' to the change of name and deletion of the suffix "university" therefrom that has been received from Dr. M S Raste, Vice Chancellor of the institution 'deemed-to-be-university' declared under Section 3 of the UGC Act 1956 [3 of 1956] vide notification in F. No. 9-12/2001- U3 dated 6/5/2002.
