



MEMORANDUM OF UNDERSTANDING

BETWEEN

SYMBIOSIS INTERNATIONAL (DEEMED UNIVERSITY) ON BEHALF OF SYMBIOSIS CENTRE FOR EDUCATION

This Memorandum of Understanding ("MoU") is entered and executed on 21 day of 12 month of 2019 (Effective Date) at Pune.

BETWEEN

Duy Tan University is a private university established on the November 11th under the decree No.666/TTg of the Prime Minister of Vietnam. Its headquarter is located on 254 Nguyen Van Linh, Thanh Khe Ward, Da Nang City 550000, Vietnam (hereinafter referred to as "DTU" which expression shall unless be repugnant to subject or context shall mean and include Officers, Authorities, Representatives, etc.,

SYMBIOSIS INTERNATIONAL (DEEMED UNIVERSITY) (SIU), an institution deemed to be a university established under Section 3 of the University Grants Commission Act, 1956 having its main campus at: Symbiosis Knowledge Village, Gram: Lavale, Taluka: Mulshi, District: Pune 411042 (India), for and on behalf of its department the Symbiosis Centre for International Education ("SCIE"), having its campus at at 3rd Floor, Symbiosis Vishwabhavan, Symbiosis

...PARTY OF THE SECOND PART

[It is clearly and distinctly understood and acknowledged that this Agreement has been executed by SIU, on behalf of Symbiosis Centre for International Education SCIE, one of its Departments Therefore, all the rights and obligations as provided in this MoU shall be exercised / performed by SCIE on behalf of SIU and hence SIU in this MoU hereafter be construed as SIU/SCIE].

DTU AND SCIE shall collectively be referred to as "PARTIES" and individually as a "PARTY"

WHEREAS, DTU, considered the first and the largest private, multidisciplinary institution in Central Vietnam, has partnered with more than fifty universities worldwide, eagerly participated in many well-known international organizations and expanded relationships with big international enterprises operating in Viet Nam. These lay a sound foundation for DTU to gain more impressive achievements in education and research, contributing to create highly qualified workforce for Vietnam.

AND WHEREAS, SCIE is engaged in providing leadership and support to internationalize the campus and the curricula. International students from over 85 countries pursue their undergraduate and postgraduate studies at Symbiosis and SCIE aims to provide the Students and faculty with opportunities to pursue their international academic interests to the fullest, be it through academic exchanges, or exposure to international conferences, seminars, workshops, and other resources.

AND WHEREAS, DTU and SCIE are desirous to collaborate in order to promote cooperation and the advancement of academic and educational exchanges.

NOW THEREFORE, the parties have decided to enter into this MoU on terms and conditions mutually agreed and recorded hereunder.

- DTU and SCIE agree to collaborate for the following activities in academic areas of mutual interest:
 - Collaborative teaching and publication opportunities in the mutually agreed areas of academic interests (inter-disciplinary) such as Software Engineering, Data Science, Enterprise Systems.
 - 2. Collaborative students' projects in the areas of Artificial Intelligence, Block chain in various industry domains.
 - 3. Funded Research opportunities with Indian and Vietnamese funding agencies, if any.
 - 4. Other forms of academic cooperation which shall be mutually decided
- 2. The purpose of this MoU is only to express the intentions of the Parties. The term of cooperation for each specific activity contemplated under this Memorandum of Understanding shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that activity. Any such activities agreed upon will be recorded and governed by a separate document executed by both parties. Each party shall designate a liaison officer to develop and coordinate the specific activities agreed upon. This MoU imposes no financial obligations on either party. Both parties understand that all financial arrangements will have to be negotiated and will depend on the availability of funds.
- 3. This MoU will remain in force for five years with the understanding that either party may terminate it by giving the other party a written notice twelve months in advance, unless an earlier termination is mutually agreed upon. In any case, on going activities shall not be affected.
- 4. Either Party shall not make any public announcement or statement or publish or release any information in relation to any proposed activity or proposed collaboration without the prior written approval of the other party. Each party shall keep confidential any information that it receives from the other party which is marked confidential or which a party notifies the other party is confidential.
