**MEMORANDUM OF UNDERSTANDING
BETWEEN
FORDHAM UNIVERSITY, GABELLI SCHOOL OF BUSINESS
BRONX, NEW YORK
AND
SYMBIOSIS INTERNATIONAL (DEEMED UNIVERSITY), INDIA**

- 1) Fordham University, a not-for-profit educational institution chartered by Special Act of the Legislature of the State of New York, United States of America, with a principal campus located at 441 East Fordham Road, Bronx, New York 10458, acting on behalf of its Gabelli School of Business (Gabelli) and Symbiosis International (Deemed University) with a campus at Symbiosis Knowledge Village, Gram, Lavale, Taluka, Mulshi, District: Pune 411042, India hereby agree to encourage academic co-operation through research and study as stipulated below. Specific details of any activity can be set forth in a Supplemental Letter of Agreement (SLOA) which, upon signing shall become an integral part of this Memorandum of Understanding (MoU).

Purpose of the MoU:

- a) To encourage visits by faculty and students from one university to the other for the purpose of engaging in research and education;
 - b) To facilitate the admission of qualified students from one university to the other for the purpose of enrolling in graduate programs, and in the case of advanced graduate students, participating in research;
 - c) To foster the exchange of academic publications and scholarly information; and
 - d) To promote other academic activities which enhance the above mentioned goals
- 2) Both universities acknowledge that the visit by faculty and students from one university to another shall be subject to the entry and visa regulations of the United States of America and India and shall comply with the regulations and policies of Gabelli and Symbiosis International (Deemed University).
 - 3) Both universities agree that all expenses, including research materials, international and domestic travel, per diem, honoraria and all other costs, shall be the responsibility of the home university and determined on a case-by-case basis. However, each side will do its utmost to make available university accommodation to visiting faculty and students.

- 4) This MoU shall take effect when signed by both parties, and will remain in effect for an initial period of five (5) years. After five (5) years, both universities agree to evaluate this MoU for future co-operation. Both universities acknowledge that this MoU is subject to revision and termination without cause at any time by mutual consent, or by six (6) months' written notice by either party.
