- Exchange of publications and relevant academic and scholarly information
- Joint research, lectures and symposia
- Other activities such as deemed appropriate by mutual consent

Financial arrangements and stipulations concerning the exchange of students, faculty and staff members are to be specifically described in detail in separate addenda.

Modifications and/or amendments to this Memorandum can be done by mutual consent.


Should either institution wishes to terminate this Memorandum, written notice should be given three months in advance of the desired termination date.

This Memorandum will enter into effect from the date duly signed by the designated officials of the respective institutions. The effective period is five years and it will be extended for another years as long as neither party expresses a desire to terminate or modify this Memorandum.


