Research findings, once published in a peer reviewed document, help the researcher to receive recognition for the value of the evidence generated and contribution to the knowledge.

- **Policy on Local Community Engagement, 2019:** This policy aims to define and guide, the communication and engagement mechanism that various departments of SIU adopt while engaging with the local community, and also provides a unified mechanism to effectively monitor, and report the progress achieved as a result of community engagement.
- **Policy on Community Outreach and Extension Initiative, 2019 :** This document aims to define community outreach and extension activities that are conducted at SIU at various levels, provide a unified mechanism to effectively monitor, evaluate and report the progress achieved by every community outreach activity and measure and report the impact achieved by each activity.
- **Gender Policy, 2019 :** Symbiosis International (Deemed University) invariably takes an active role in the field of academia emphasizing the necessity of policies that establish equality and equity among all its members irrespective of their race, nationality, faith, gender, or others. Through its forward-thinking culture and gender-just practices, the University promotes at the highest level of critical thought, objectivity, freedom from discrimination, and transparency. In doing so, it seeks to establish a culture and community deeply rooted in principles of respect and equality
- **Rules for Promotion of Academic Integrity and Prevention of Plagiarism, 2019:** "Academic Integrity" means intellectual honesty in proposing, performing and reporting any activity, which leads to the creation of intellectual property.  
At Symbiosis International (Deemed University), it is ensured that research is conducted in a responsible manner. In this regard, the University has constituted an Independent Ethics Committee (IEC), which looks after responsible conduct of experiments on animals, clinical trials on human and other research related activities influencing the humans. This policy will provide the insights on Responsible Conduct of Research (RCR) and help the researchers to avoid departures from accepted ethical research practices and prevent those most serious deviations that constitute research misconduct.
- **Policy on Data Access from SIU :** Researchers working in Higher Education Institutions (HEI) are, in general, keen to collect data for research from the subjects who are a part of the University, that is, the students, teachers or staff of the University because of easy availability and access. However, this gives rise to several ethical and methodological issues in research and needs comprehensive policy guidelines to minimise the adverse effect of the issues that arise.

Following sections develop the background for the policy on "Data Collection for Research from the Subjects from within the University" (henceforth, in-house data collection) and subsequently followed by the criteria for giving permission to researchers for the same and the precautionary actions that must be taken for ensuring the ethical research conduct and robustness of the research methodology
