2] **AND WHEREAS**, the University Grants Commission (UGC) has published the UGC [Institutions Deemed to be Universities] Regulations, 2023, vide Notification No. F.1-1/2021(CPP-I/DU) dated 2nd June 2023, superseding the UGC [Deemed to be University] Regulations, 2019;

3] **AND WHEREAS**, the University has drafted Memorandum of Association (MoA) of the University, 2023 based on UGC [Institutions Deemed to be Universities] Regulations, 2023, which was accepted by Board of Management vide Resolution No. A5: BoM; 05.09.2024 and same has been accepted by UGC;

4] **AND WHEREAS**, the Board of Studies of Faculty of Humanities and Social Sciences has completed its tenure and the said Board of Studies has to be constituted as per the provisions of Memorandum of Association (MoA) of the University, 2023;
