### Sub.: Constitution of Board of Studies of Faculty of Law

**WHEREAS**, the Board of Studies for the Faculty of Law was constituted vide SIU/U-28/1152 dated 1st June 2022, in accordance with Clause 26 of the Memorandum of Association (MoA) of Symbiosis International (Deemed University), 2019, and Clause 2.2.5 of Chapter 2 of the Administrative Manual of Symbiosis International (Deemed University), 2020 and re-constituted vide Notification No. SIU/ U-28/ 1196 Dated 28<sup>th</sup> July, 2022 & Notification No. SIU/ U-28/ 1369 Dated 15<sup>th</sup> December, 2023;

2] **AND WHEREAS**, the University Grants Commission (UGC) has published the UGC [Institutions Deemed to be Universities] Regulations, 2023, vide Notification No. F.1-1/2021(CPP-I/DU) dated 2<sup>nd</sup> June 2023, superseding the UGC [Deemed to be University] Regulations, 2019;

3] **AND WHEREAS**, the University has drafted Memorandum of Association (MoA) of the University, 2023 based on UGC [Institutions Deemed to be Universities] Regulations, 2023, which was accepted by Board of Management vide Resolution No. A5: BoM; 05.09.2024 and same has been accepted by UGC;

4] **AND WHEREAS**, the Board of Studies of Faculty of Law has completed its tenure and the said Board of Studies has to be constituted as per the provisions of Memorandum of Association (MoA) of the University, 2023;
