This has reference to your application I.D. No. 8287-05/08/2023 seeking accreditation by National Board of Accreditation to the UG Engineering programs applied by Symbiosis Institute of Technology, Pune, Near Lupin Research Park, Gram Lavale, Tal Mulshi, Pune-412115, Maharashtra.

2. An Expert Team conducted onsite evaluation of the programs from 01<sup>st</sup> to 03<sup>rd</sup> March, 2024. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The Competent Authority in NBA has approved the following accreditation status to the programs as given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. In case of the UG Engineering program which has been granted full accreditation for 6 years in Tier I January 2016 Document, the program should be applied in Tier I Second Cycle SAR document at least five months before the expiry of validity of accreditation mentioned above.
5. In case of the UG Engineering programs which have been granted accreditation for 3 years, **Symbiosis Institute of Technology, Pune, Near Lupin Research Park, Gram Lavale, Tal Mulshi, Pune-412115, Maharashtra** should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.
6. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Symbiosis Institute of Technology, Pune, Near Lupin Research Park, Gram Lavale, Tal Mulshi, Pune-412115, Maharashtra** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.
7. The accreditation status of the above programs is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited programs as indicated in the table in paragraph 2, appears on the website and information bulletin of the Institute.
8. The accreditation status awarded to the programs as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.

10. If the Institute is not satisfied with the decision of NBA, it may appeal within thirty days of receipt of this communication giving reasons for the same and by paying the requisite fee.
