## **Annual Placement Cell Report (2022-23)**

Symbiosis International (Deemed University) is a multi-disciplinary university offering its students and faculty an effervescent learning ecosystem designed around its multicultural and pioneering tenet. Established in 1971 by eminent visionary educationist Prof. Dr. S.B. Mujumdar, it is a 'home away from home' for students. The Institution is based on the principles of Vedic thought of 'Vasudeva Kutumbhkam' which translates as "World as One Family".

SLS, Nagpur, which was established in the year 2019, offers two integrated undergraduate Five years law courses in Bachelor of Arts and Bachelor of Laws (B.A. LL.B.) and Bachelor of Business Administration and Bachelor of Laws (B.B.A. LL.B.) and one year LL.M. program offering specialization in Business and Corporate Law and Criminal Law and Security Law to cater to diverse needs of the legal profession. These are imparted through well qualified, experienced, fervent and zealous faculty, techno-driven research culture, Internationalization, centers of excellence, training and skill enhancement programs, moot courts etc. The curricular augmentation is ensured with the involvement of judges, eminent lawyers, International jurists, academicians, industry experts etc. and best practices are reflected in teaching-learning pedagogy.

### **Placement and Internships:**

Symbiosis Law School, Nagpur has career mentoring and counselling programs that encompasses not only the Placement Cell but the faculty members from all the areas of practice, assisting the students in identifying their areas of focus and appreciating different career paths while making the apt selection for themselves.

The Placement Cell goes beyond providing final placements by engaging with top advocates, lawyers, law firms and corporates on various fronts namely, Internship Drives for students, and Placement Assistance for the students of all the programs.

During the academic year 2022-23, the Training & Placement Cell has provided winter internships to over 300 students across the country in various Law firms, Advocate Offices, Courts, Tribunals, NGOs, Research Organizations, Think tanks etc.

During their internship period, students take up the Project Work that imparts significant learning. The students have to be in touch with their concerned faculty members as well as mentors at their workplace, hence their progress can be guided and monitored properly.

### **Placement of LL.M. students:**

In the year 2022-23, there were a total of 23 students pursuing an LL.M. from the institute. Out of these 23 students, 3 students opted to be placed through the placement cell of the institute. Few of these students are practicing advocates, while some showed interest in joining the teaching profession and hence wished to pursue further education.
